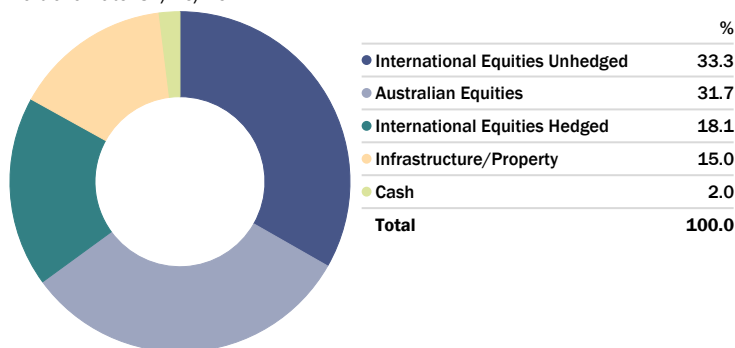

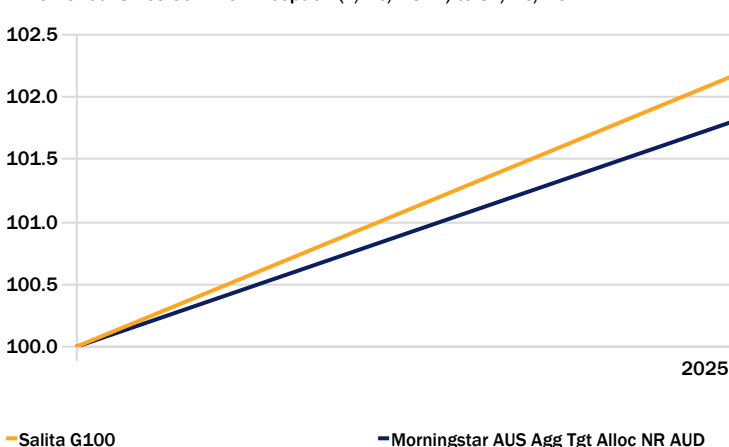
Asset Allocation

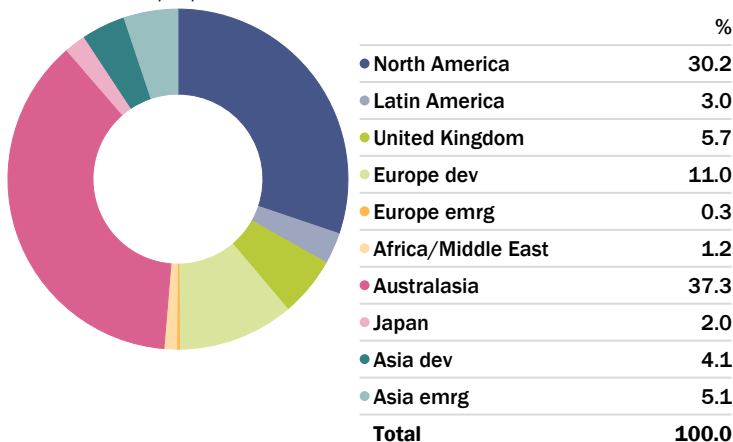

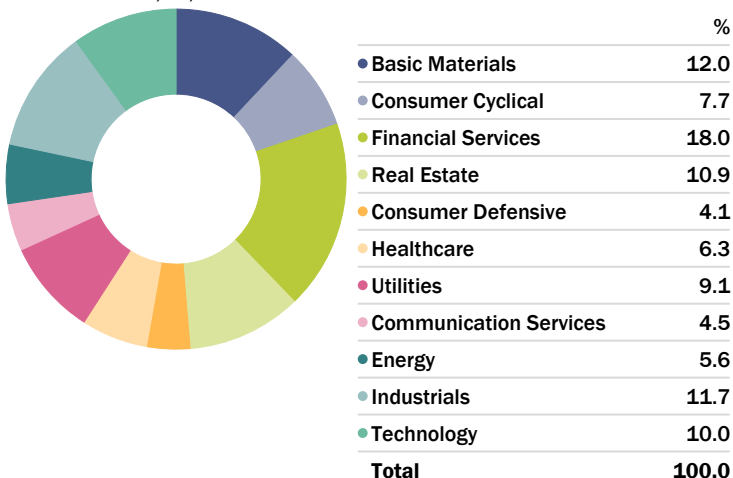
Equity Regional Exposure

Portfolio Date: 31/10/2025



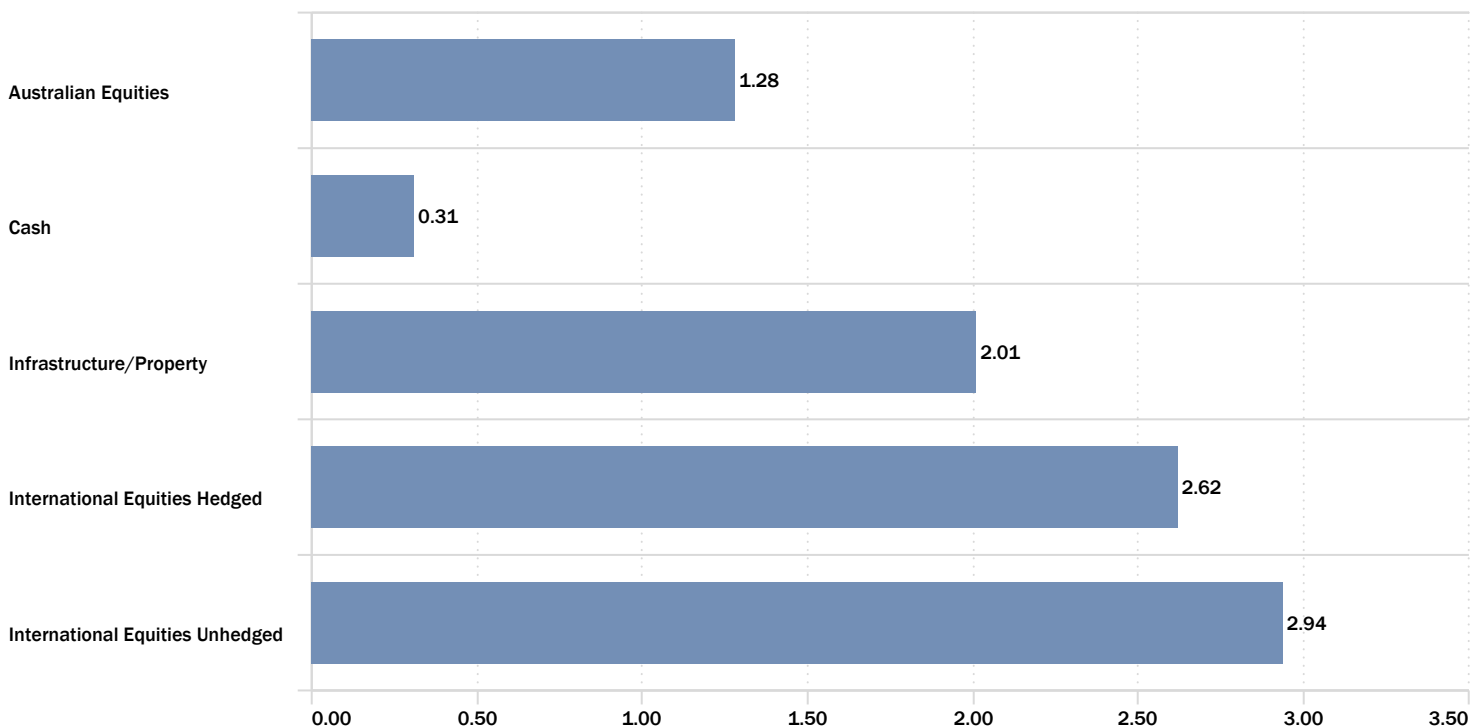
Equity Sector (Morningstar)
