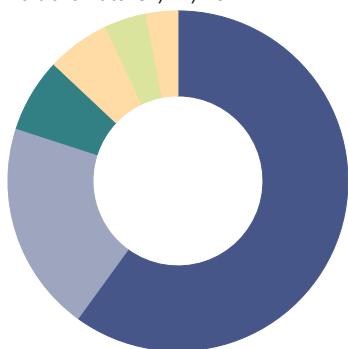

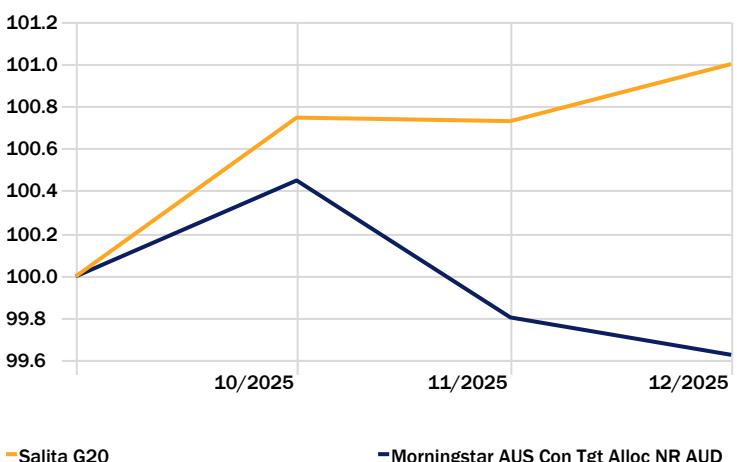

Time Period: 1/10/2025 to 31/12/2025



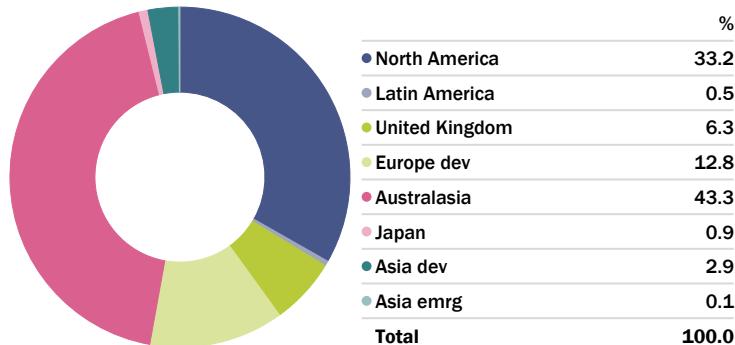

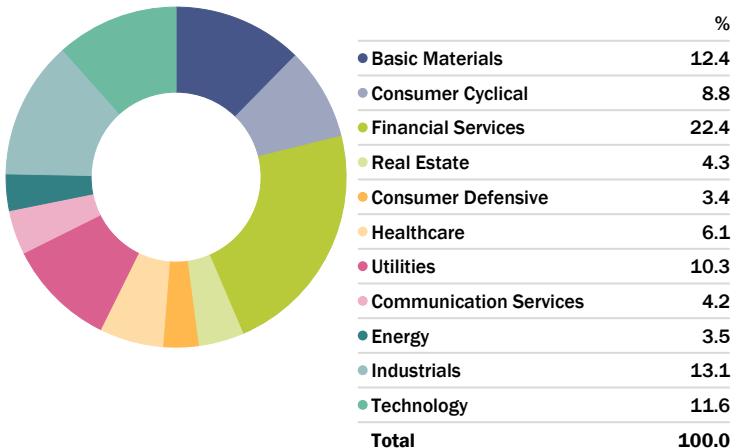
#### Equity Regional Exposure

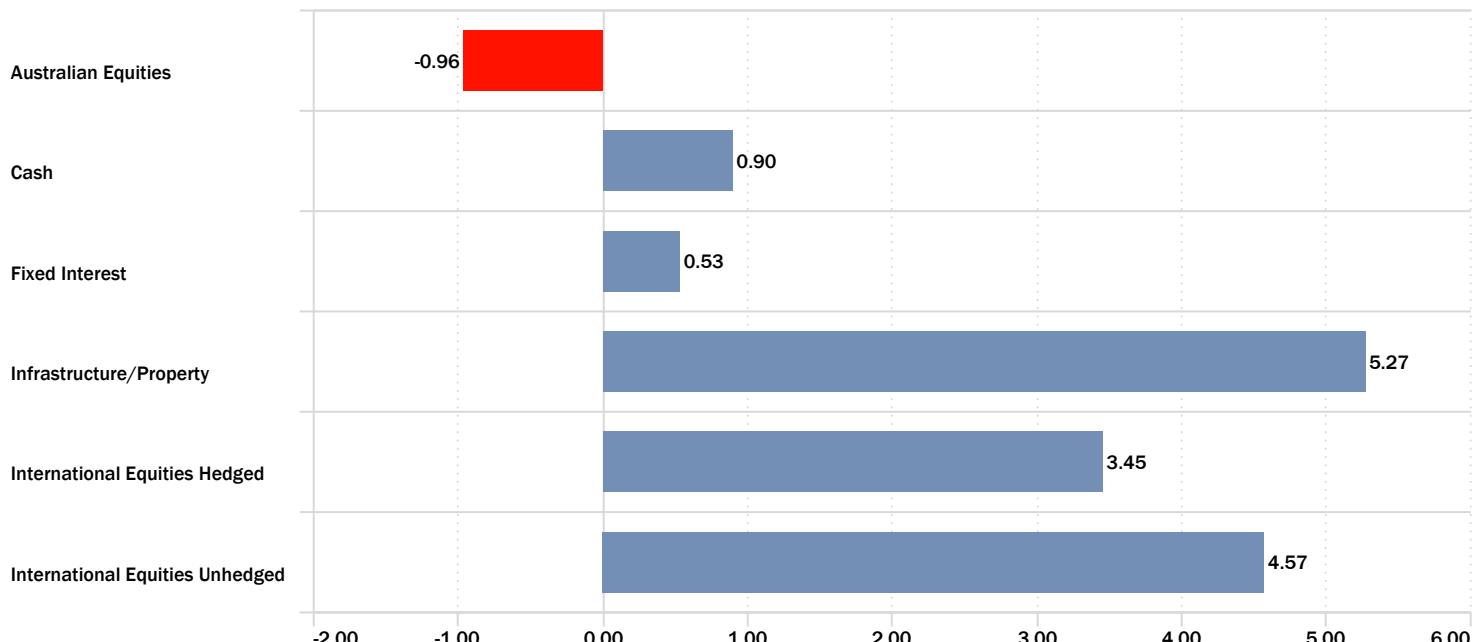
#### Equity Sectors (Morningstar)
