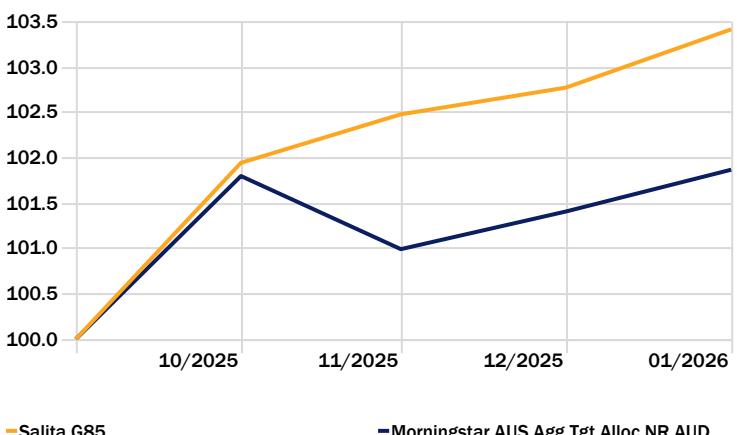

Time Period: 1/10/2025 to 31/01/2026



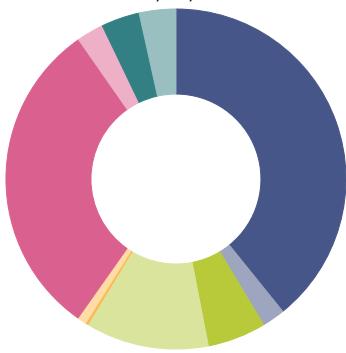

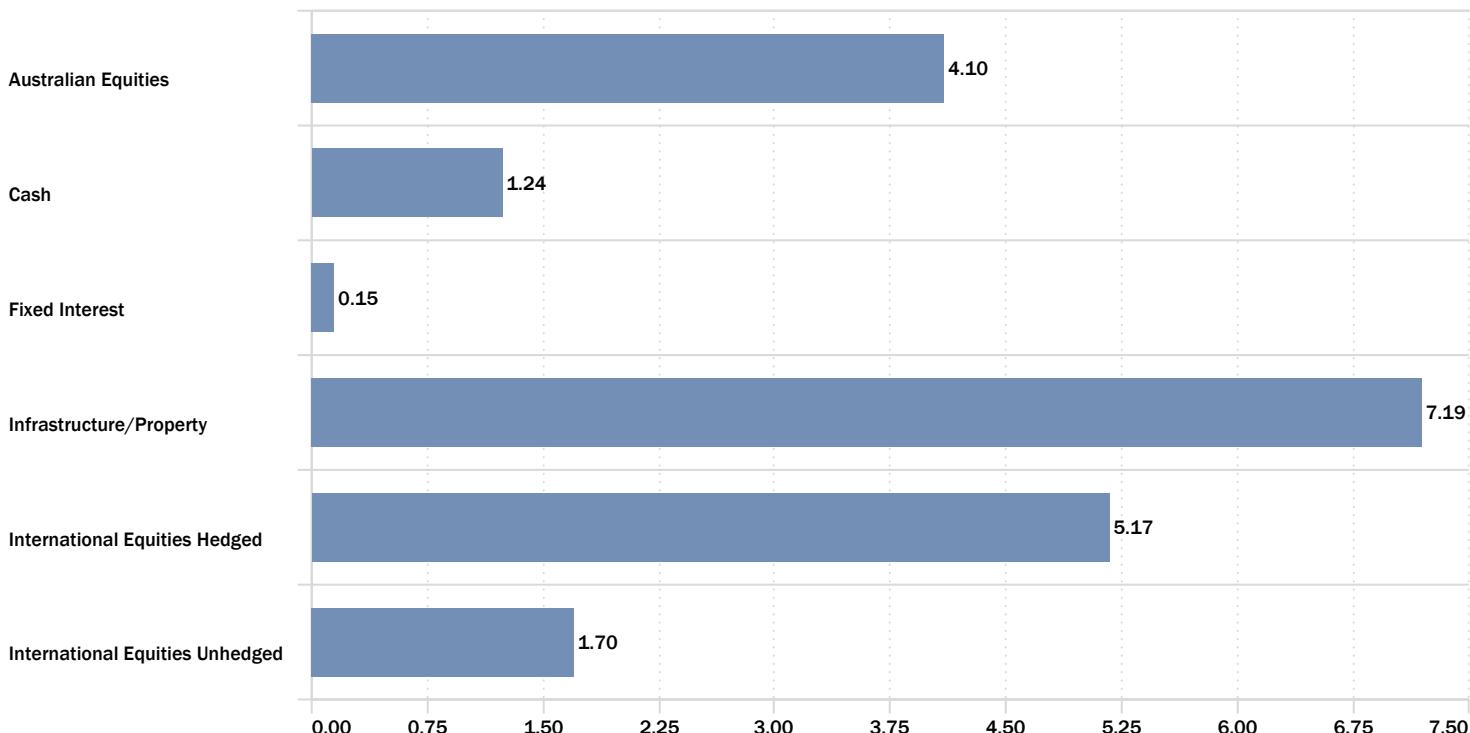
