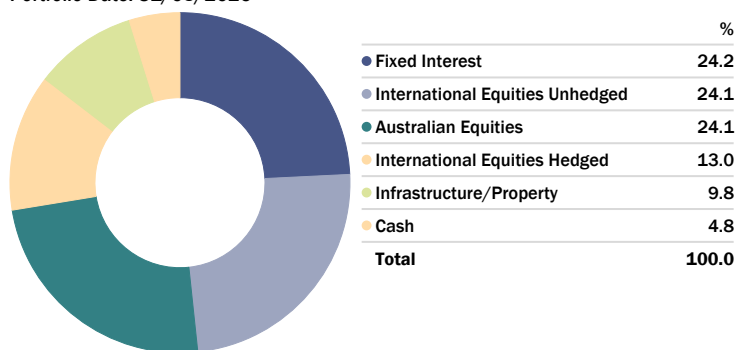

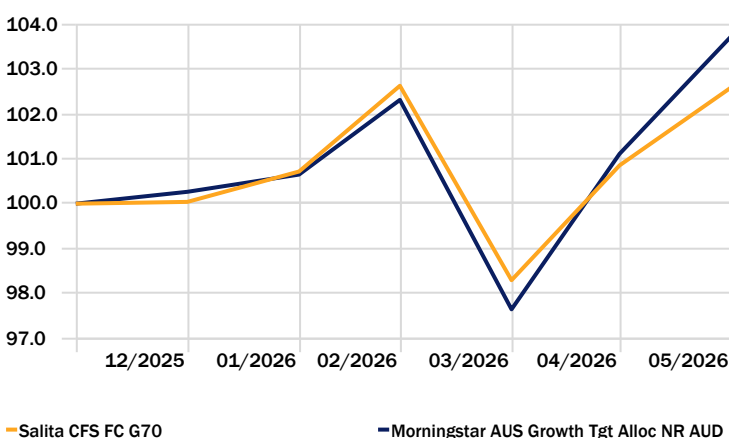
## Asset Allocation

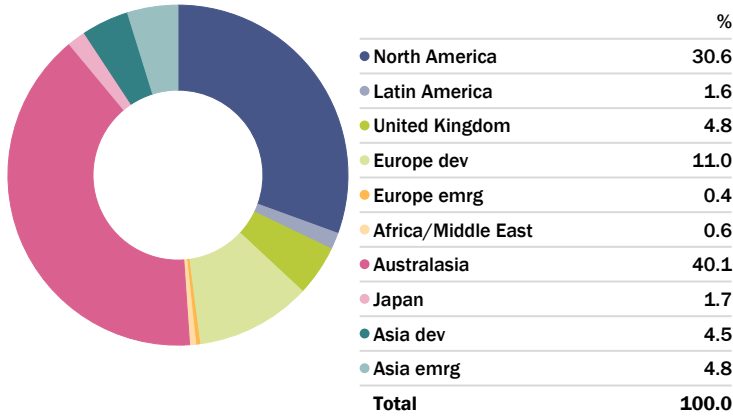

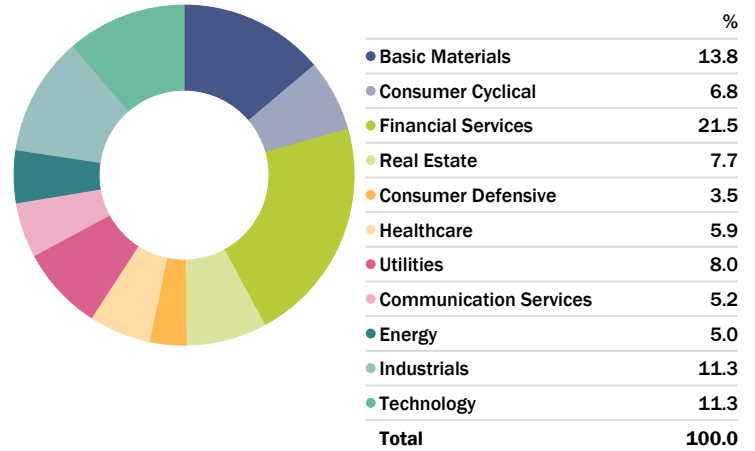
**Equity Regional Exposure**

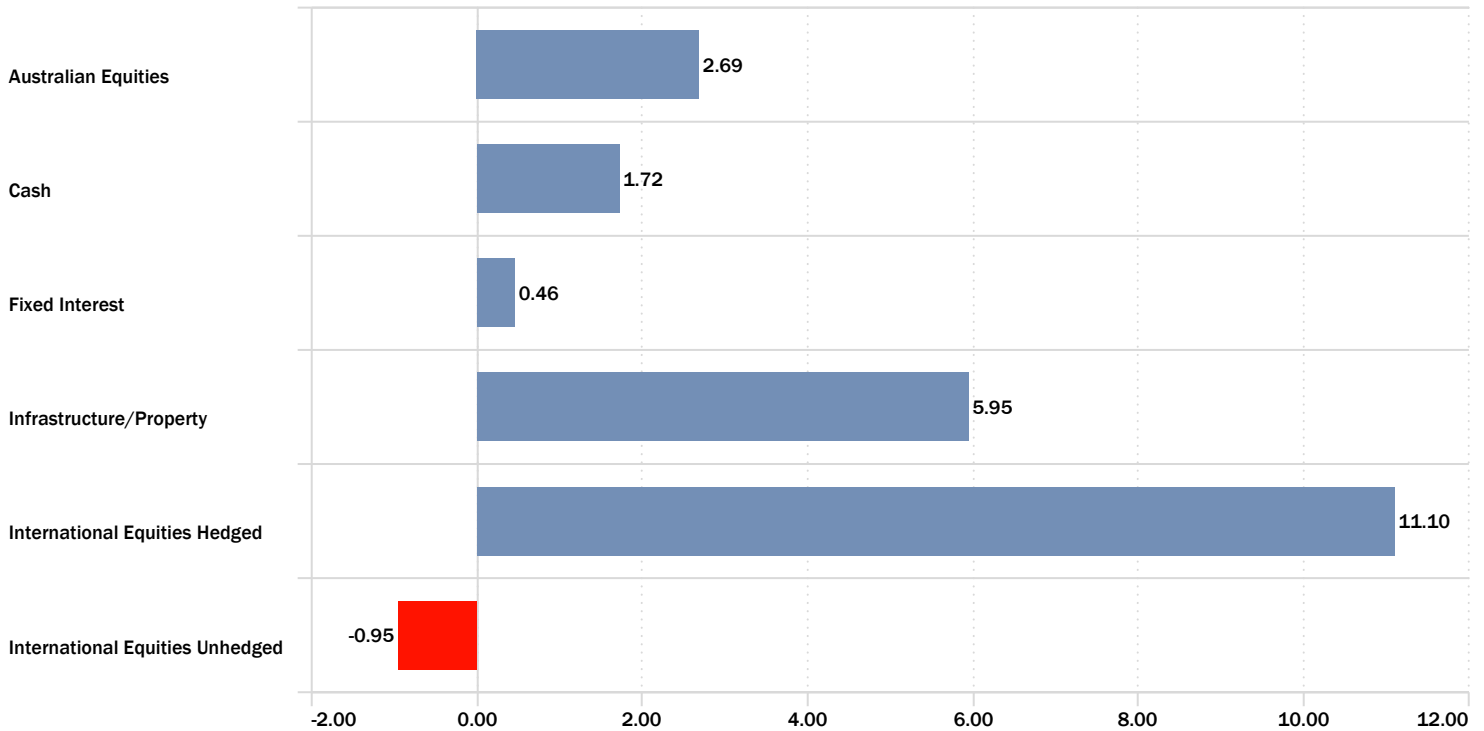
**Equity Sectors (Morningstar)**
