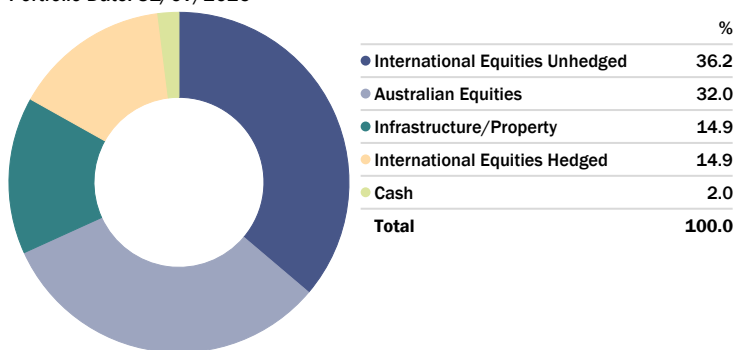

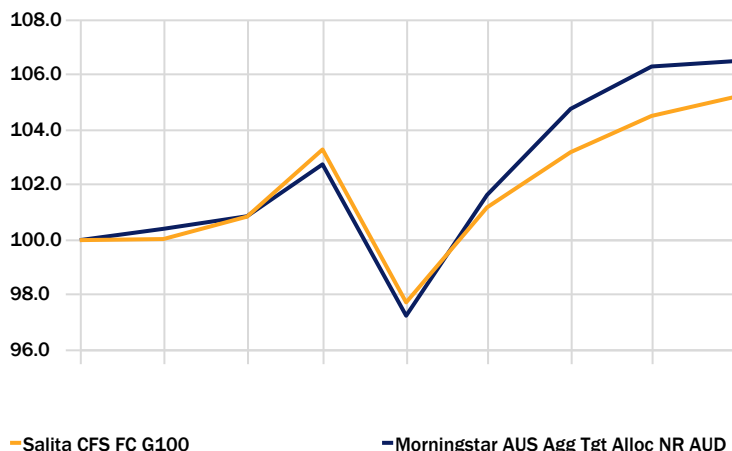
Asset Allocation

Time Period: 30/11/2025 to 31/07/2026



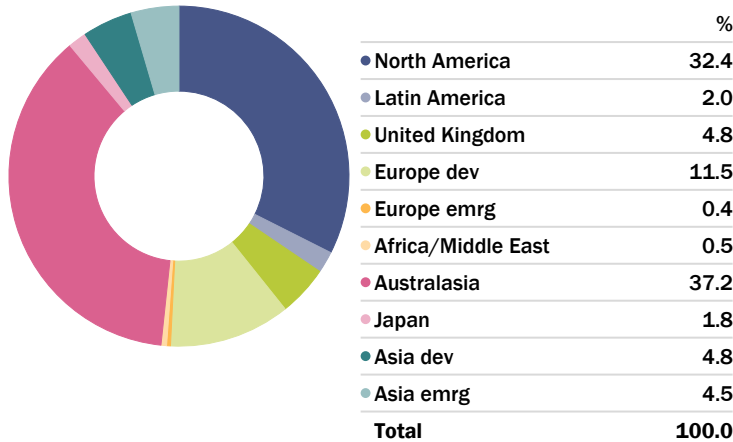

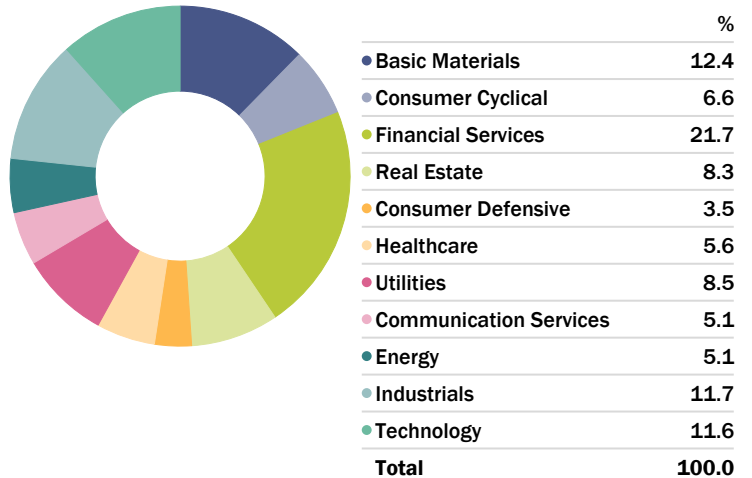
Equity Regional Exposure

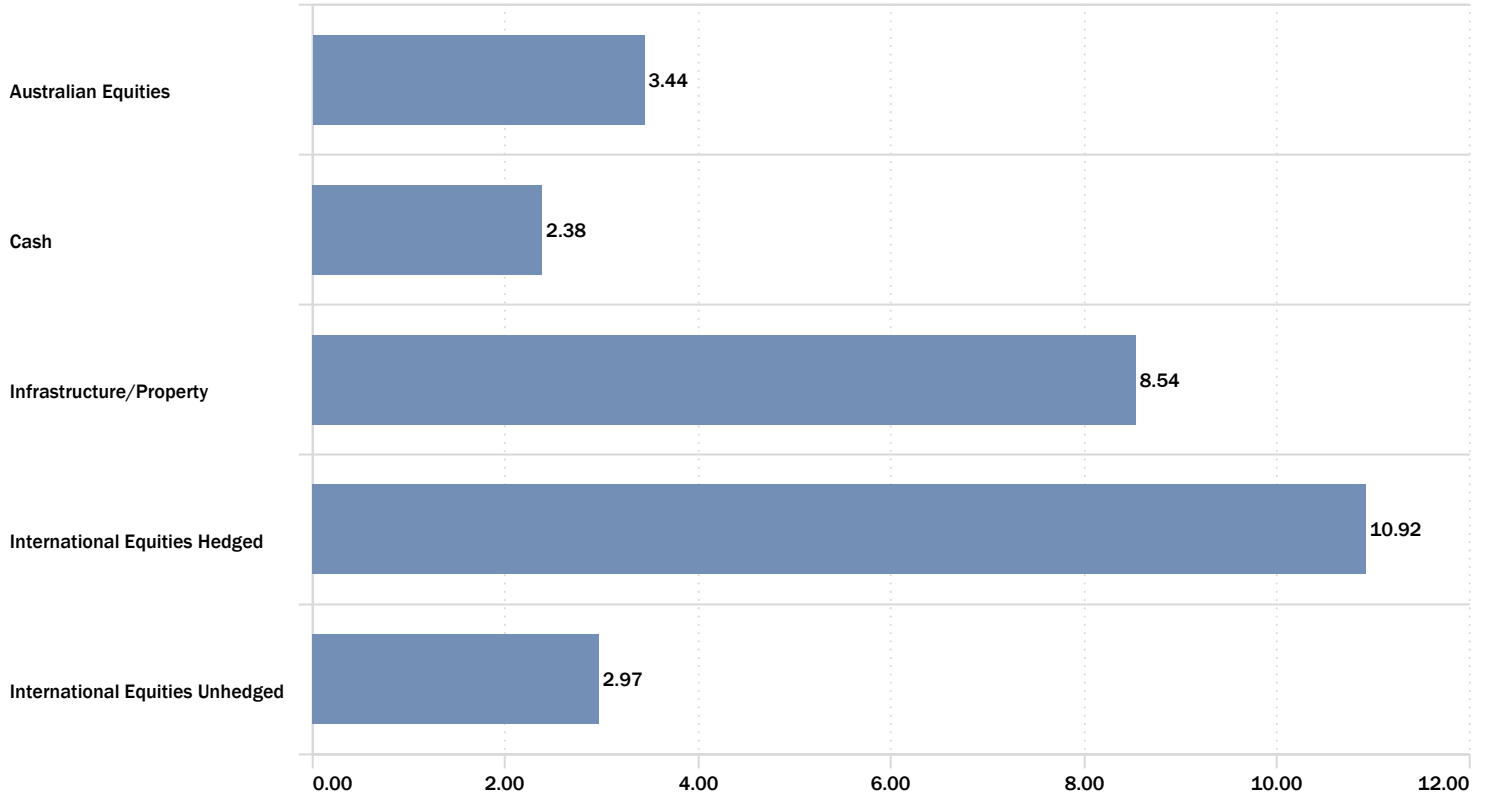
Equity Sector (Morningstar)
