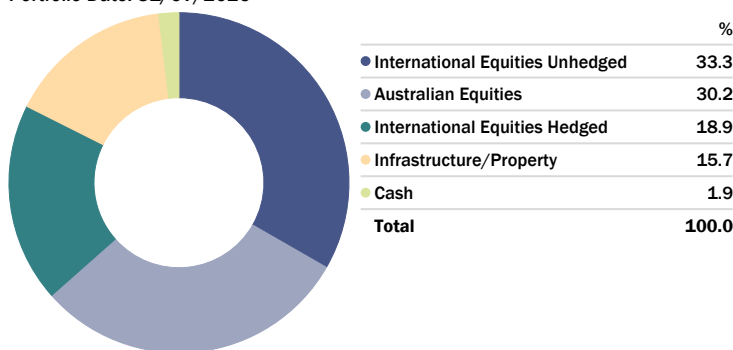

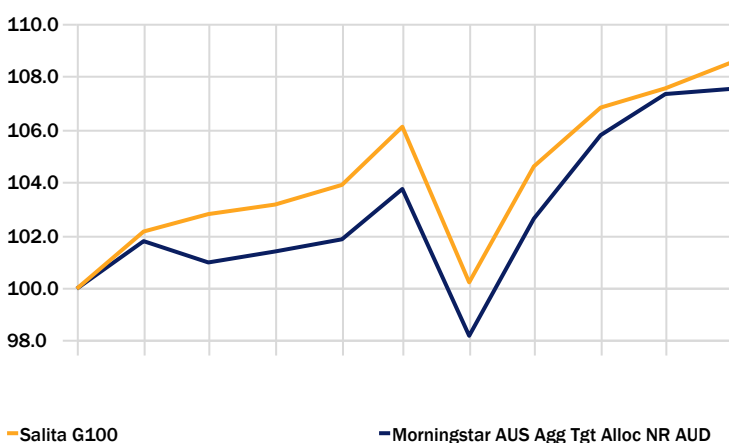
Asset Allocation

Time Period: Since Common Inception (1/10/2025) to 31/07/2026



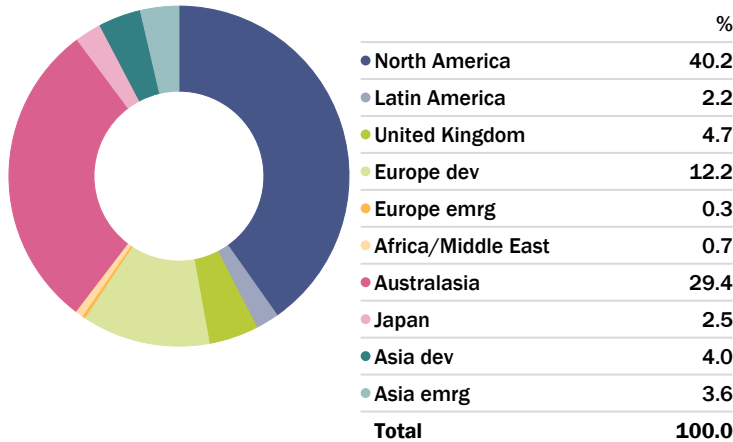

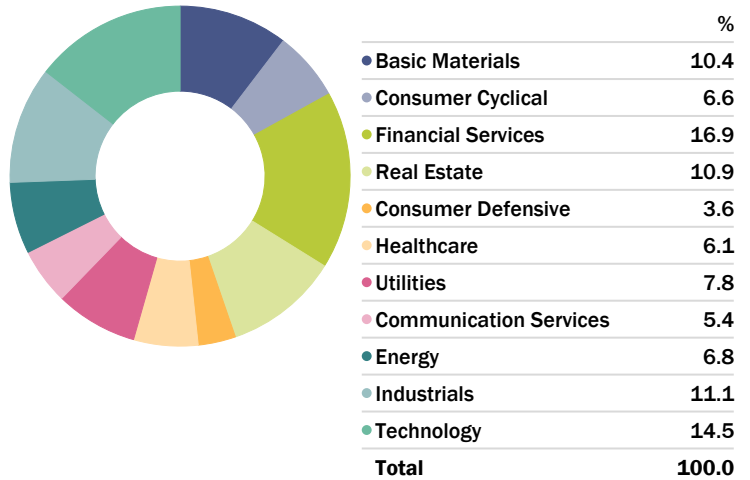
Equity Regional Exposure

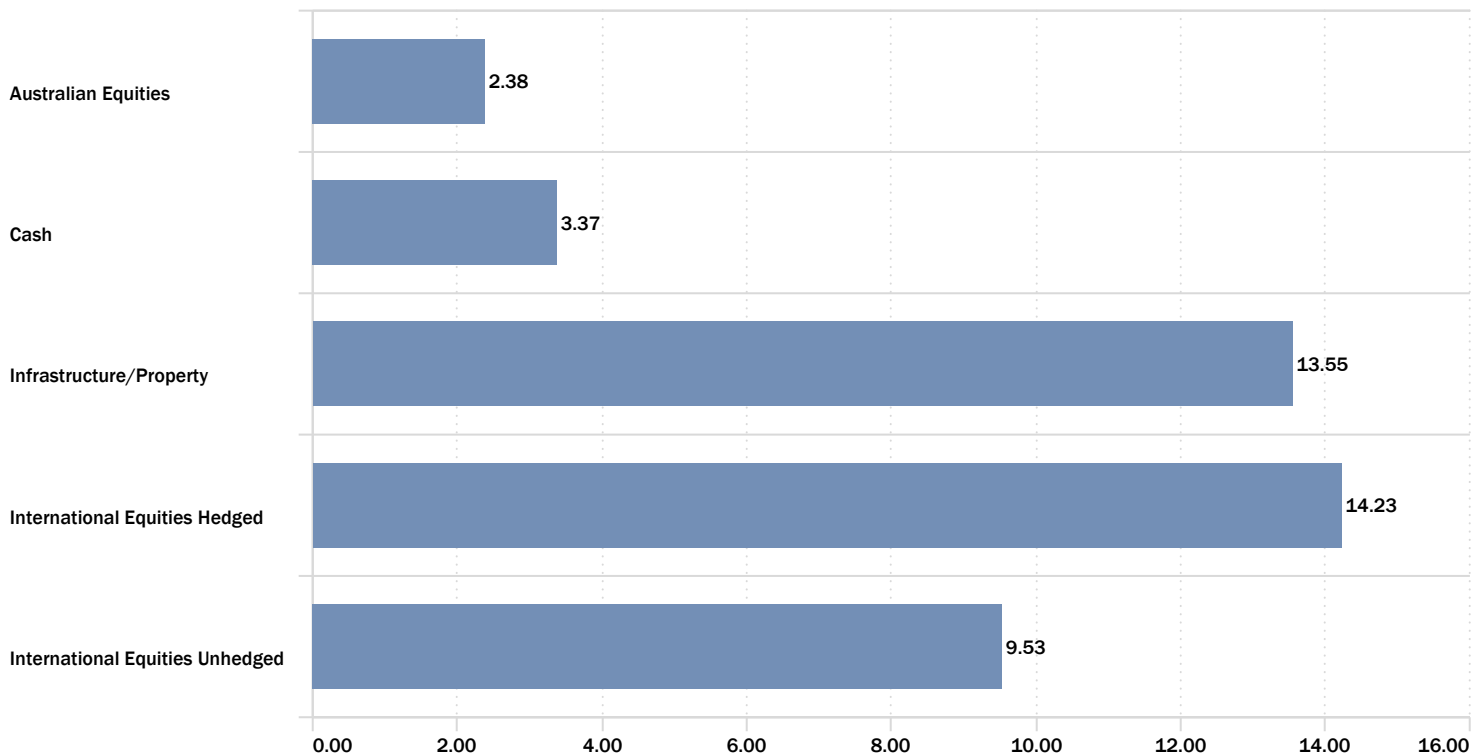
Equity Sector (Morningstar)
