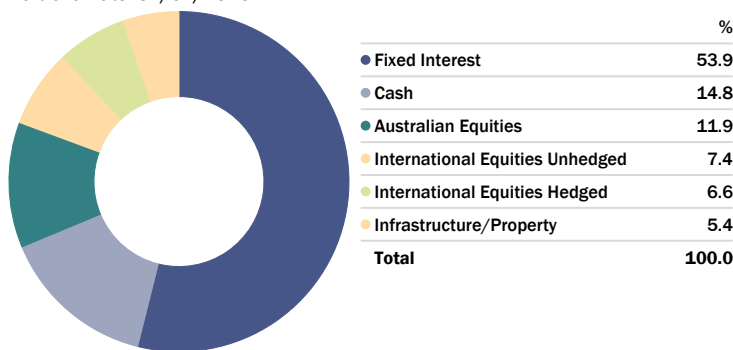

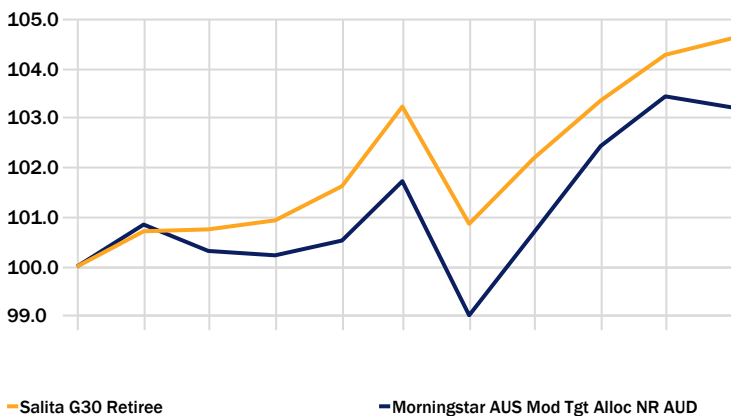
Asset Allocation

Time Period: 1/10/2025 to 31/07/2026

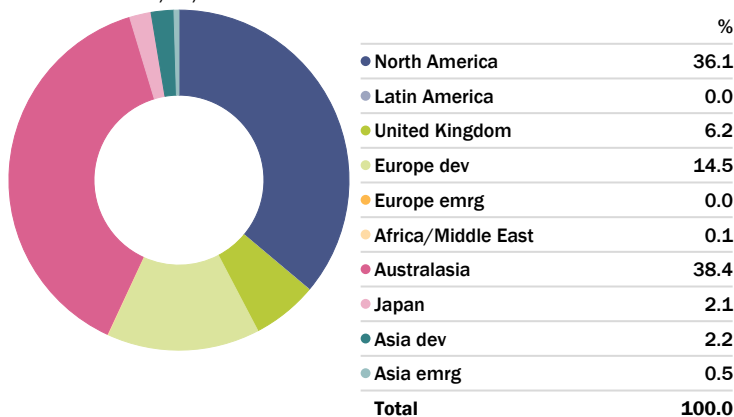

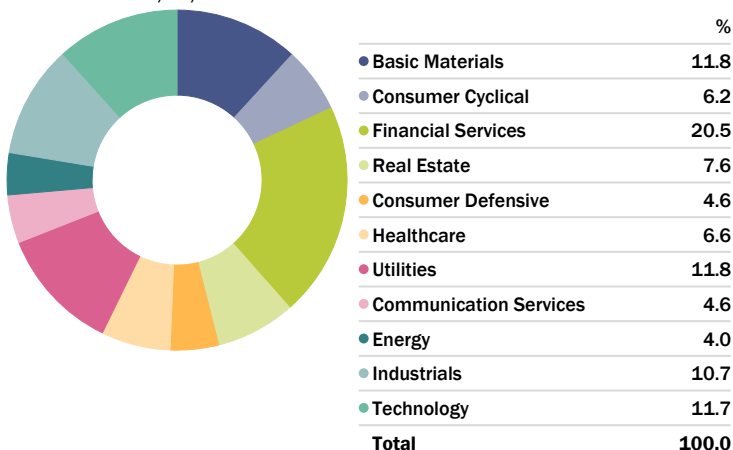
Equity Regional Exposure

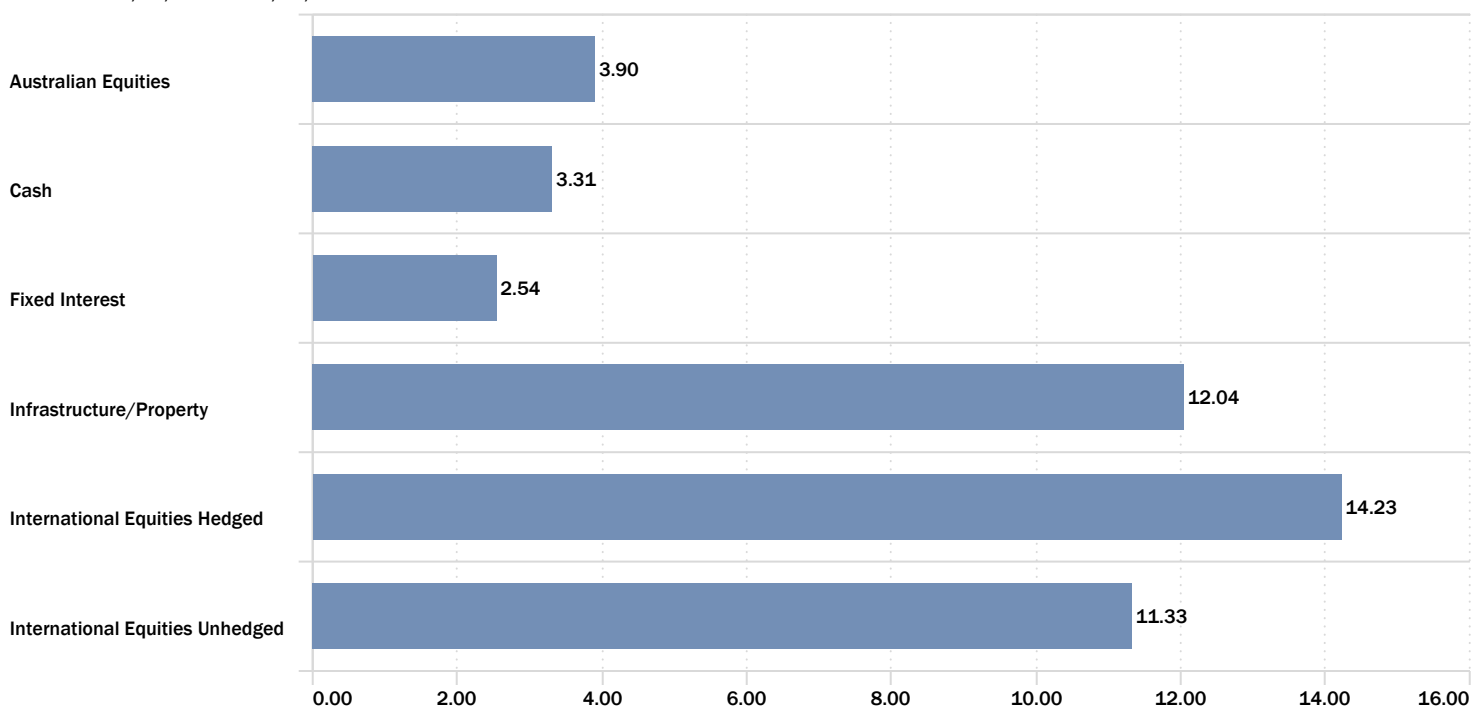
Equity Sectors (Morningstar)
