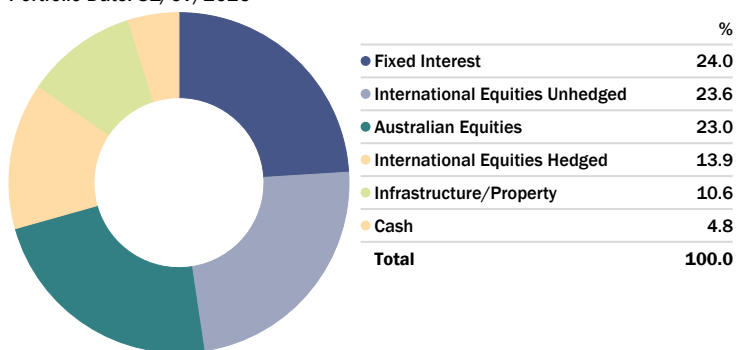

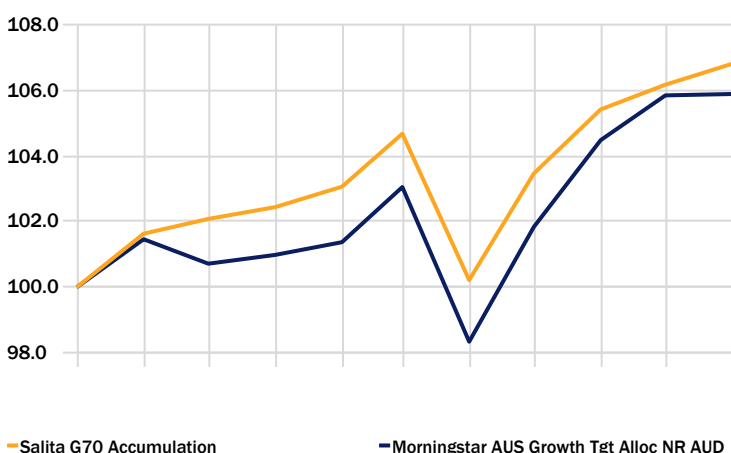
## Asset Allocation

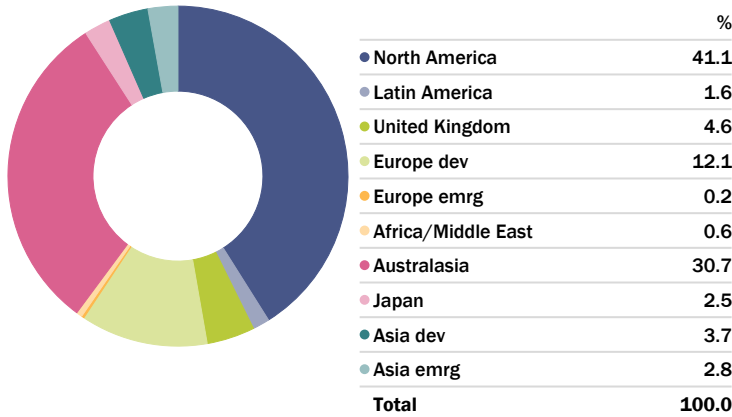

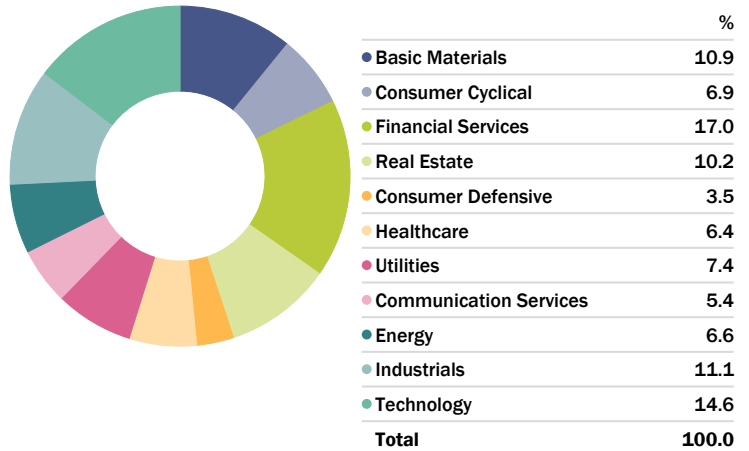
## Equity Regional Exposure

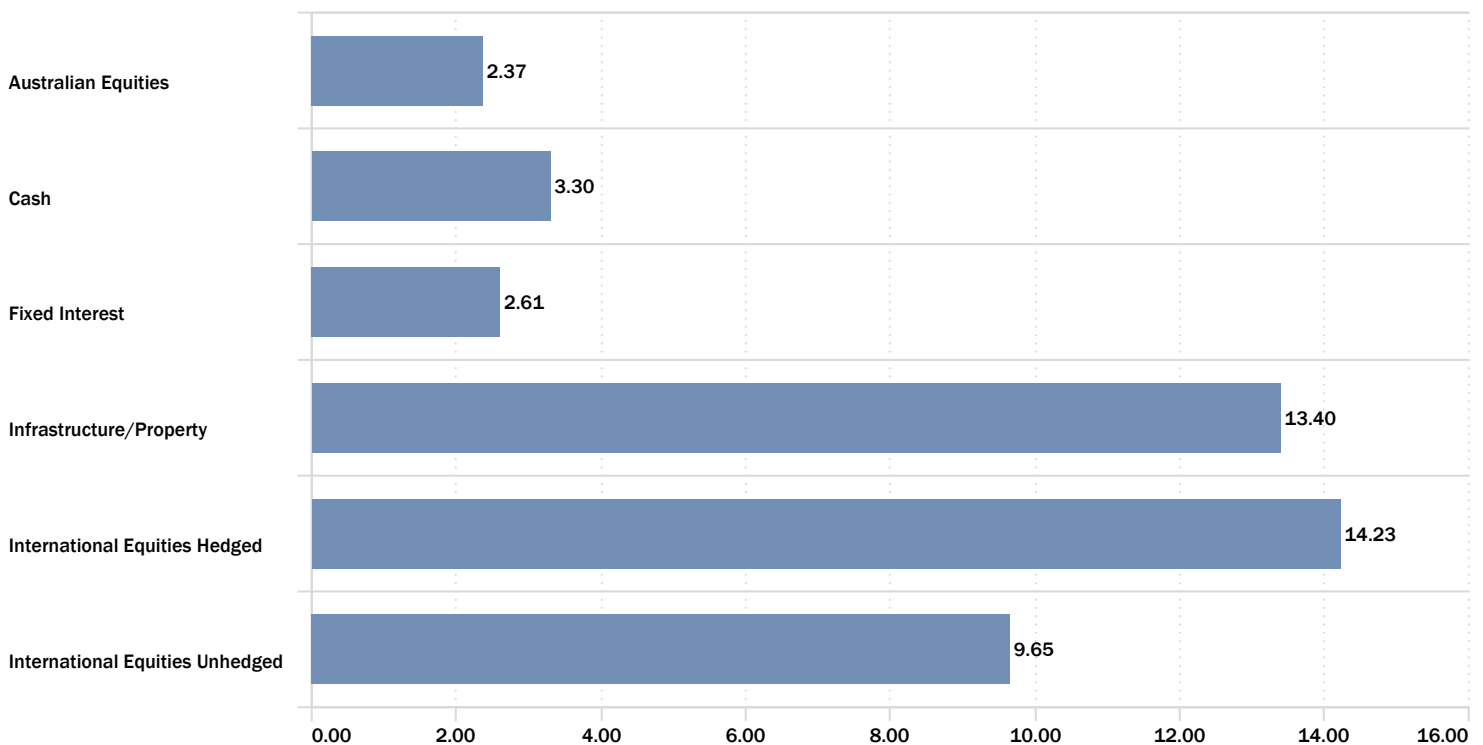
## Equity Sectors (Morningstar)
