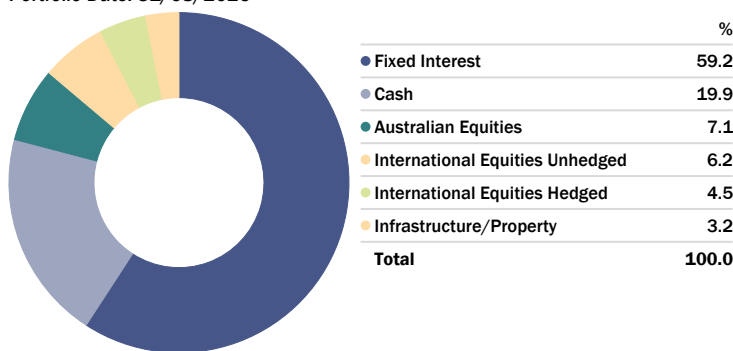

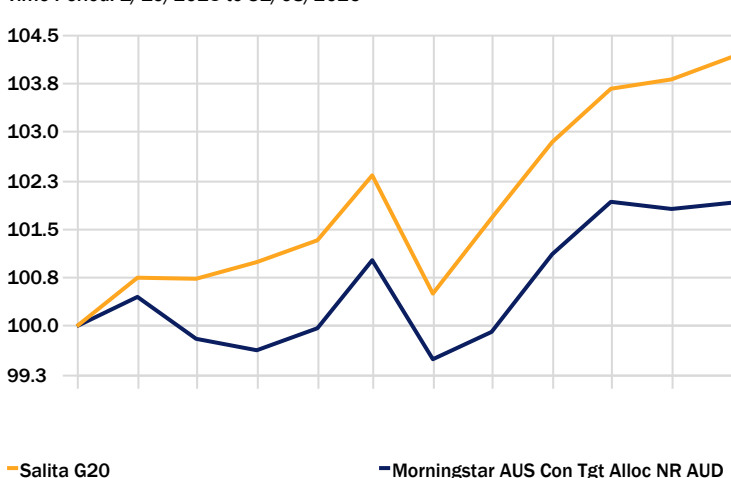
Asset Allocation

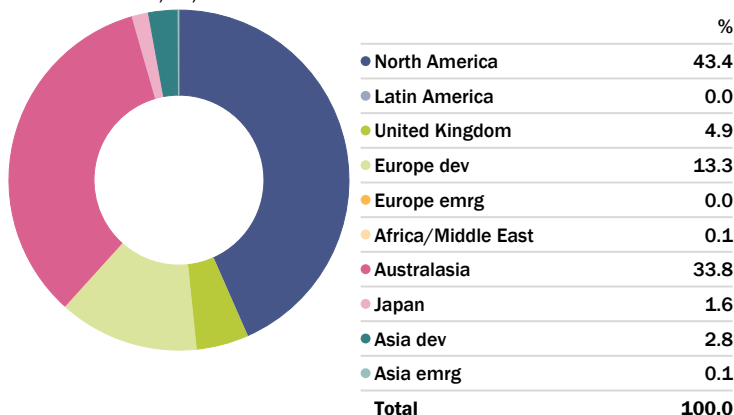

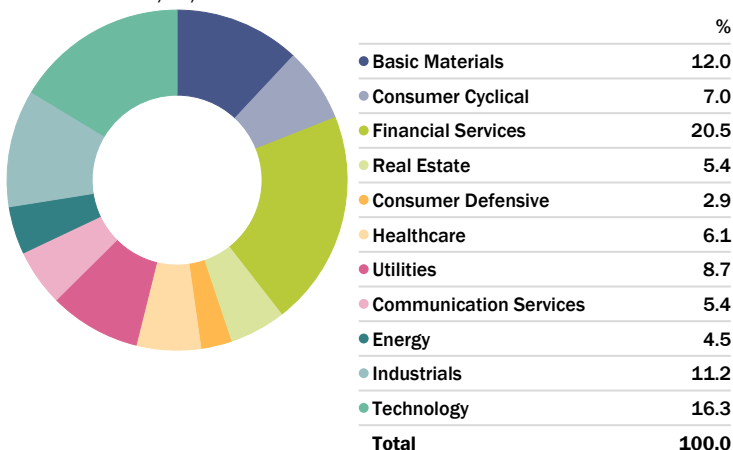
Equity Regional Exposure

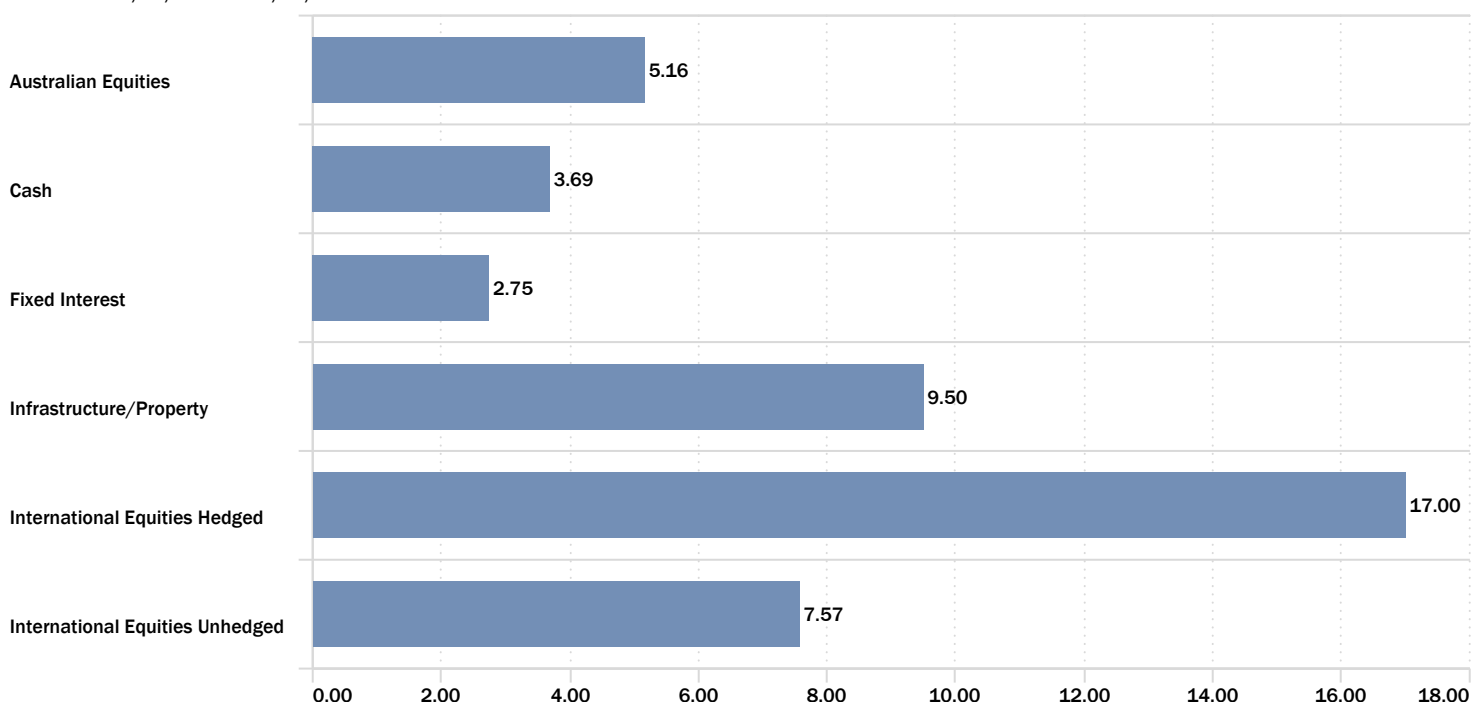
Equity Sectors (Morningstar)
